**PERMISSION TO SHOOT**  
**APPROVAL OF PARENT/GUARDIAN(S)**



(For Scouts and Venturers (*under 16 years of age*) participating in BB gun, pellet gun, rifle, & shotgun instruction and shooting.)

New York State Law requires that in order for campers to participate in the rifle or shotgun areas, they must be at least 12 years old. Council policy is that individuals be at least 10 years old or a Webelos Scout to participate in bb-gun. All individuals under the age of 16 who wish to participate in any of the shooting sports at the Challenge Trophy Camporee **MUST** have this permission to shoot form completed by their parent or guardian in order for their child to participate in any of these activities. **FOR THIS CAMPOREE participants MUST be 13 years old or older in order to participate in the shotgun shooting activity.**

Further, I attest that the Scout has a current, signed BSA Annual Health and Medical Record (AHMR) Part A on file with the Scout's unit. On this form, I have explicitly given my consent for the Scout to use BB guns, or (if the older form is being used), I do so now. I give permission for my child to use a BB device.

Further, I understand that the AMHR (Part A) contains a general Release Agreement clause. My signature here serves to reaffirm my agreement to the entirety of the 'Informed Consent, Release Agreement, and Authorization' found in the AHMR.

I understand that all shooting will be conducted under the supervision of appropriately certified NRA/BSA instructors. In addition, any time the participants are shooting at a rifle or shotgun range, they will be supervised by an NRA certified range officer. All activities will be done in compliance with the BSA National Shooting Sports Manual, The Guide to Safe Scouting and all applicable New York State and Federal laws and regulations.
